To order documents from the National Library of Australia's Document Supply Service online using Loansome Doc, you must first complete the User Agreement above. The completed and signed form should be returned by mail or fax to the National Library of Australia Document Supply Service.

CONDITIONS OF SERVICE

1. The copyright declaration applies to published works only. If a copyright declaration is not signed, the request will be treated as a Copyright Fee Paid Service request.
2. You must use the Copyright Fee Paid Service if your request does not comply with the fair dealing and library provisions of the Australian Copyright Act 1968. More information about the Copyright Fee Paid Service is available from the National Library of Australia Document Supply Service.
3. The National Library of Australia will debit your credit card for documents supplied. No charge will be made where the document cannot be supplied.
4. The National Library of Australia will supply the document from its own collections wherever possible. Turnaround time for material supplied from the National Library's own collection is usually 3-4 days. Material not held by the National Library will be obtained from outside sources. Delivery time cannot be guaranteed for these documents. However reasonable effort will be made to obtain the documents as soon as possible. Depending on the source of supply, time will vary from 2 days to up to 10 days, or longer for hard to access documents. If the document is mailed, please add delivery time to these turnaround times.
5. The National Library of Australia will make reasonable efforts to obtain any requested documents but cannot guarantee that it can supply all documents requested. If the document cannot be obtained you will be notified without delay. You will not be charged for documents not obtained.
