To the Independent Electors of the City of Sydney.

**G**ENTLEMEN,—I beg to announce to you that it is my intention to offer myself as a candidate for the honour of representing your City in the first Session of the new Legislative Council. After having laboured among you for the last eighteen years, in concert with other friends of freedom, to obtain those constitutional privileges, which are the rightful inheritance of Britons and their descendants, in whatever quarter of the empire they may reside, I trust,—now that the parent Legislature has at length conceded to us a portion of our birthright, that I may be permitted to found my claim to your support, on the part I have taken in procuring this important concession,—tardy—as it has been, and imperfect and unsatisfactory—as it still is.

My public principles have been so often before the public, in the course of the long and arduous struggle, which has led to this approaching change in our form of government, that I do not consider it necessary to trouble you with a recapitulation of them now:—feeling confident, that my veneration for civil and religious liberty, and for all the free and expansive elements of our happy constitution, will not be doubted by any one who is acquainted with my public career.

Should it be your pleasure to elect me to the distinguished honour of being one of your first representatives, I pledge myself to deal with all measures, that may be propounded to the Council, according only to my deliberate views of their probable tendency, come from what quarter they may: giving to whatever I may deem beneficial to the general weal, my cordial support; and to whatever I may judge detrimental, my strenuous opposition.

A son of the soil myself, it must be almost needless to add, that my whole interests, feelings, and prejudices, are identified with the prosperity of my country—a prosperity which, I know, can only be insured by free institutions and equal laws. To revive and re-establish that prosperity on lasting foundations is evidently the first want of the colony, and will be the first duty of its new Legislature.

After having devoted the best energies of my life to promote the interests of my country, I trust it will not be deemed presumptuous in me to anticipate, that few will be found in its Councils more competent to assist in extricating it from its difficulties; still fewer—with more experience, purer intentions, or greater zeal.
