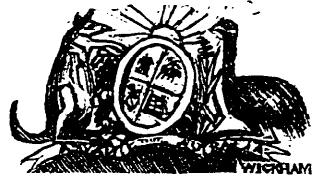

PORT PHILLIP.

**EXTRAORDINARY DEATH**.—An inquest was  
held at the "Rose Thistle and Shamrock Inn,"  
Elizabeth-street, on view of the body of Wil-  
liam Noble, who had come to his death under  
the following circumstances:—

John Hinde deposed.—I am a blacksmith  
and reside near the "Kinlochewe Inn;" on  
Friday week last, (27th day of February,) the  
deceased was leading about a mare, my prop-  
erty, for the purpose of breaking her in, and  
after being absent about five minutes he re-  
turned, and said the mare had laid down with  
him and that he had trodden on a piece of  
glass bottle; I found the deceased was bleed-  
ing very much from a wound on the side of his  
leg; he went to Mr. Budds the innkeeper and  
got it bandaged up, and he remained there all  
night; the following morning he returned to  
my house, and the exertion of the walk caused  
the wound to bleed afresh; on the following  
morning it again burst out bleeding, and I  
bandaged it anew; I urged upon the deceased  
the necessity of having medical advice, but he  
declined; on the Friday morning I became  
alarmed and sent for Dr. Wilson, who attended  
and ordered the wound not to be disturbed,  
and if it again commenced to bleed, to send  
for him, which I did on Saturday morning  
when it bled a little, but before he arrived  
ceased to exist.

Thomas Wilson, Esq., M.D.—I reside on  
my farm and occasionally practice my profes-  
sion; on Friday morning last I was called upon  
to visit deceased professionally, and I lost no  
time in seeing him; on arrival, I found the

bleeding had ceased, and the part being prop-  
erly bandaged, I did not deem it prudent to  
disturb it; deceased appeared to be much  
weakened from the loss of blood, but was free  
from pain, and the part felt cool; I gave such  
directions as I judged right, and ordered the  
person watching him to come for me immedi-  
ately if the bleeding should be renewed, and  
to tighten the bandage as directed till I could  
arrive; I was sent for the following morning  
but deceased had expired before I left my  
house; I believe the loss of a small quantity  
of blood in a weak state in which I found  
deceased would have caused death; and I am of  
opinion had timely surgical aid been called in,  
deceased would not have expired.

The Jury returned the following verdict:—  
"That the deceased, William Noble, was acci-  
dentally killed in consequence of a wound in  
his leg caused by a broken portion of a glass  
bottle, whereby certain blood-vessels were cut,  
the bleeding from which was so profuse as to  
cause the death of the deceased William  
Noble."—*Courier*.

Miss Lord.—The *Courier* contains an able  
and affecting letter upon the miserable fate of  
this unfortunate lady, and adds the following  
as their own remarks:—

The idea of a Christian woman being in such a situ-  
ation is so horrifying, that not a moment ought to be  
lost in instituting an immediate search among the blacks  
in the locality in question. It is preposterous to say  
that His Honor the Superintendent has not the means at  
his disposal without previous reference to the Governor,  
of proceeding to the rescue, for he has it perfectly in his  
power to call the services of the Mounted, Border, and  
Native Police into requisition, and if all these are suffi-  
cient, he may, if he will, have the military also. We  
cannot say, however, that we give implicit credence to  
the report our correspondent refers to, though we are  
equally anxious to have its truth or falsehood investi-  
gated. There was a search made when this report was  
originally circulated, not one but several years ago, but  
no ground-work for it could then be obtained; besides,  
the Britomart, the vessel in which Miss Lord is stated to  
have been a passenger, was not wrecked on this coast,  
but among the islands in Bass' Straits.

One of the native police assert that he has,  
on a recent trip to Gipps' Land, seen a white  
woman with two half caste children, in com-  
pany with a large body of aborigines of the  
above district. The woman attempted to lag  
behind, to give the native policemen an oppor-  
tunity of rescuing her, which was quickly per-  
ceived by her captors, who urged her before  
them at the point of their spears; in fact, the  
man who relates these facts, saw one of the  
savages plunge his spear into her leg to quicken  
her retreat. The policeman would have made  
an attempt to liberate her, but from the nature  
of the ground (a marsh) in which he was  
standing, up to his knees in water, he was un-  
able to overtake the savages. The unfortunate  
prisoner is supposed to be Miss Lord, lost in  
the Britomart, wrecked near Wilson's Pro-  
montory, some four or five years since. The  
Government should lose no time in taking  
active steps for the release of the wretched  
woman from her disgusting fate; nay, the in-  
habitants should insist on such steps being  
taken without delay. The enterprise of private  
individuals may be excited when we inform  
them that one thousand pounds have been  
offered for the lady's recovery.

A NEW NAME FOR A BYE-BLOW.—A BILLI-  
OUS RESPONSIBILITY.—A female appeared be-  
fore the Melbourne police bench, dandling in  
her arms a little bilious responsibility respecting  
the paternity of which Mr. John Stephen, the  
advocate and friend of "beauty in distress,"  
gave a very vivid description, laying the onus  
upon one Thomas Moran, late of Geelong, who  
stood at the bar, twiddling his fingers and  
thumbs, and looking remarkably stupid, while  
he admitted the soft impeachment. The bench  
directed that he should pay three shillings  
weekly for the support of the child; three and  
sixpence costs, and twenty shillings for the  
expenses the woman had been put to.—*Patriot*.

SOUTH AUSTRALIA.

CAPTAIN STURT.—The dinner given to this

were present; the *South Australian* remarks,  
that "as a testimony of respect by the intel-

FATAL ACCIDENT.—A most distressing and  
fatal occurrence horrified St. Catherine street  
and its neighbourhood on Monday afternoon  
last, about three o'clock, by which in an instant  
a married woman was, under most awful cir-  
cumstances, hurried instantaneously into eter-  
nity. Mrs. Eliza Baylis, wife of Mr. Baylis,  
butcher, of St. Catherine Street, had been  
washing some offal meat at the pump, with  
which to feed a dog and cat, and this operation  
attracted around her some other dogs and cats  
from neighbouring houses. In order to cut up  
the meat, she had taken one of her husband's  
sharp-pointed knives, and leaning forward to  
drive away one of the cats, her foot slipped and  
she fell on her face to the ground. She sprang  
up again instantly and uttered a scream of pain,  
and immediately a perfect torrent of blood  
gushed from her mouth, and she fell dead. A  
neighbour, Mrs. Webb, was standing near her  
at the time, and called assistance, and Mr.  
Wather, surgeon, was immediately sent for.  
It was at first supposed that the knife had pen-  
etrated her mouth, but on examination it was  
found that the instrument had entered her left  
breast just above the nipple. The ill-fated  
woman had, no doubt, the knife upright in her  
hand when she fell, and the whole weight of  
her body coming upon it, it entered her heart,  
causing the gush of blood from her mouth, and  
producing death almost immediately after-  
wards. The blade of the knife was eight  
inches in length, and it is supposed penetrated  
the unhappy woman's body up to the haft.  
The deceased was 37 years of age, was mar-  
ried as above stated, but has left no children,  
and she was an exceedingly well conducted  
woman. An inquest was held on the body be-  
fore Mr. Lovegrove, coroner, and a verdict re-  
turned of "Accidental death."—*Gloucester  
Journal*.
