

THE THISTLE STEAMER.—From a correspondence which appears in the Sydney Morning Herald of Friday, June 23rd, between Mr. Francis Clarke, the Hunter River Steam Navigation Company's manager, and Captain Pattison, it appears that the reason why the Thistle steamer did not go down the river to Newcastle to bring up a party of Mr. Scott's friends on the day of the nomination was that Mr. Chambers, Mr. Scott's agent, and Mr. Cohen, of the Rose Inn, told Capt. P. that other arrangements had been made, and that Dr. Harrington had gone by the Shamrock to Newcastle for that purpose, and that consequently the Thistle was not wanted.

WEST MAITLAND CATHOLIC CHAPEL.—This place of worship, which has long been inconveniently small for the rapidly increasing congregation attending it, has during the last fortnight been undergoing a considerable addition, which is now very nearly completed, and when finished will afford accommodation to upwards of eighty persons more than there was room for previously.

APPREHENSION OF A SUSPECTED ROBBER.—A day or two ago Mr. Wood, the chief constable, apprehended a man on the road near Cock-fighter's Creek on suspicion of his being a prisoner illegally at large. He gave his name as Michael Brown, and stated that he was a free man on his way from Windsor to Liverpool Plains, but he afterwards said that he was going to Bathurst, and that he had a certificate of freedom ten years ago, but he had lost it. Mr. Wood suspected from the appearance of the man that he was one of the persons who had been recently engaged in the robberies committed in the vicinity of the Parramatta and Liverpool roads, and for whose apprehension a reward was offered in the Government Gazette of May 23rd. He was ordered to be forwarded to Sydney to be identified.

A BOISTEROUS CUSTOMER.—On Monday morning last a man named John Henson, who had been given in charge by Mr. Cox, of the Union Hotel, on the previous Saturday, was brought before the police bench charged with disorderly conduct. It appeared that on Saturday the prisoner was insulting almost every person about Mr. Cox's house, and Mr. Cox gave him in charge to constable Rafferty. Henson was very drunk and outrageous, kicked Mr. Cox and the constable, and bit the latter severely on the hand. It was with great difficulty that he was secured by the assistance of four or five other constables. The above facts having been clearly proved against him, the bench sentenced him to pay a fine of 40s., or to be imprisoned in Newcastle gaol for one month. He was allowed until Friday to pay the fine.

A DOG FOND OF MUTTON.—Yesterday afternoon a dog, in passing Mr. Hyland's butcher's shop, cast his eye upon a fine neck of mutton, to which he took a fancy, and jumping on the block seized it in his mouth, and trotted off, apparently well pleased with his prize. He was observed, however, and followed, but as he kept on at a pretty good pace he was not so easily to be overtaken. In the meantime he came up with his owner, who very comely took the mutton from him, and wrapped it in his pocket handkerchief; as, however, he did not travel quite so fast as his canine companion, he was shortly overtaken, and the mutton was restored to its right owner. NEWCASTLE.

POLICE OFFICE.

(Before Major Crumner, P.M.)

BURGLARY.—On Friday, June 23rd, a man named George Hurpur, per Earl Grey, assigned to the Australian Agricultural Company, was brought before the police bench charged with burglary on the premises of Mr. Alexander Flood, postmaster, of this town. It appeared that between three and four o'clock on the above morning Mr. Flood arose from bed and lighted a candle, for the purpose of awakening his man servant to be in readiness to go to the wharf with the mail bags, when he discovered several articles of wearing apparel lying about, and suddenly he observed under the table in his sitting room the prisoner Harpur, who, finding he was detected, made a spring at the candle which Mr. Flood held, and knocked it out of his hand, leaving them in darkness. The noise thus occasioned awoke Mrs. Flood, who, although greatly agitated, ran out of the house by the back entrance, and procured the assistance of Mr. M'Greavly, who with Mr. Croft and Mr. Crosswell came up all about the same time, and found the burglar struggling with Mr. Flood in the yard. Mr. Flood had given the robber a severe thrashing previous to their arrival, but not before the fellow had contrived to break through the window sash, frame, &c., and inflicted severe injury on the person of Simon Smith, the servant of Mr. Flood. The evidence of the prosecutor being confirmed by that of the several witnesses, the bench committed the prisoner for trial.

ASSAULT.—On Tuesday last John Malowney, per Westmoreland, assigned to the Australian Agricultural Company, was arraigned on a charge of assault, with intent to commit some grievous bodily harm. The prosecutor, John Parry, deposed that on the evening of Monday, June 19th, about nine o'clock, he was sitting in the parlour of Rouse's inn, when the prisoner attempted to enter the room, on which the prosecutor rose and prevented him. Shortly afterwards, on his leaving the room, Malowney came up to him and struck him a severe blow on his face, which knocked him down, and on his being raised up by some persons who witnessed the assault the prisoner drew a clasp knife and inflicted a deep wound upon Parry's head. The wound was attended to by a medical gentleman, and a few days afterwards the prisoner was apprehended. It appears the prisoner was seen about the premises for some time after the assault was committed, and no notice was taken of him. It is a matter of surprise that the prisoner, who is a notoriously depraved character, should be allowed to be abroad at so late an hour, and thus be enabled to commit a brutal assault upon a free man, and to remain at large for some days afterwards. The prisoner was fully committed to take his trial.

THE ELECTION.—The chairing of the successful candidate, Major Wentworth, took place on Friday last. The procession arrived at Newcastle in the same order that it left Maitland, as detailed in your last number. The gallant Major, after alighting from his triumphal car, addressed the inhabitants from the verandah of Mr. M'Greavly's inn. His speech was clothed in

language every way appropriate and gentlemanly, and we regret that circumstances prevented us from taking notes at the time. He was listened to with every attention and respect, and although he did not receive vehement applause at its termination, he at all events made no allusion whatever calculated to give offence to the fastidious, if any such were present, of the adverse party. The Major was followed by his brother, Mr. W. C. Wentworth, who laboured under one disadvantage, his voice being very husky and hoarse, so that his delivery was evidently painful to himself as well as to his hearers. It is to be lamented that in the course of his speech Mr. Wentworth made many reflections upon Mr. Scott, which certainly under existing circumstances might have been spared, more especially when he must have observed how extremely unpalatable they were to the supporters of the unsuccessful candidate, as on each ebullition of this nature the angry feelings of such of Mr. Scott's adherents as were present could not be suppressed. Still we must do all parties the justice to observe that a more creditable assemblage of persons meeting under such peculiar circumstances could not be found anywhere. Major Wentworth's liberality and hospitality are proverbial, and he certainly has had no reason to complain of the reception he met with at Newcastle on Friday last, although some few individuals had expressed their belief a day or two previous that "bloodshed" would ensue in the event of the Major attempting to enter the town, either by land or by water. Here we would point out the ungenerous, as well as unfounded supposition, that the peaceable inhabitants of this town could so far degrade themselves as to vent their feelings in the manner imputed to them. This we imagine could only have been put forward with the remote view of depreciating in public opinion the zealous efforts and conscientious plans of those who had previously made arrangements for the immediate suppression of any disturbance which might occur, and who also had advised the adoption of good feeling and friendship to be observed on all sides. We may in truth observe that nothing but propriety and order characterized the proceedings of the respective friends of both parties. We think the only discordant sounds heard were those of the musical instruments, whose players seemed too weary and dispirited, after their long and tedious march from Maitland, "to discourse most eloquent music." In fact they played lively tunes in so drowsy a manner that we feared all their instruments had caught the prevailing epidemic (cold and sore throats). Most certainly Her Majesty was libelled in the attempt to play the national anthem, which was called by some wag in a fustian coat and ditto unmentionables, "the dead march." At about six o'clock in the evening, two tables were laid at Mr. M'Greavly's, one in the up stairs room and one below, at which a number of the supporters of the Major sat down to an excellent dinner, Mr. W. C. Wentworth presiding at the table in the lower room, and the Major at the one in the upper. After the cloths were withdrawn, both parties joined in the up stairs room, and the chair was occupied by Major Wentworth, supported on his right by Mr. J. Wilkinson wearing his Waterloo medal, and on his left by Mr. R. P. Cummins with the colours of the party. Several toasts were drank and speeches were delivered by the Major, Mr. W. C. Wentworth, and some other gentlemen, and the Major sung an appropriate song composed by himself. At about eleven o'clock the Major, Mr. W. C. Wentworth, and several of their friends retired to Mr. Ried's, where a ball was given, and the remainder of the night was spent in harmony and hilarity. On Saturday morning about nine o'clock the Major and his friends breakfasted at Mr. M'Greavly's, and on the arrival of the steamer, walked in procession to the wharf, from whence the Major and his talented brother proceeded to Sydney. Mr. Scott, who came down from Raymond Terrace by the Shamrock, landed and shook hands with his late opponent, and it was evident that good feeling existed between these much respected gentlemen.

ACCIDENT.—A fatal accident occurred on Monday morning last, at the well near the engine of the old coal pit. A poor fellow named John Chandler, assigned to the Australian Agricultural Company, was with some others engaged in drawing water for the boiler of the engine, and some obstruction having occurred at the bottom of the well, which is a very deep one, Chandler jumped upon the rope to go down and remove it, but owing to the rope being wet and slippery he could not hold sufficiently fast, and fell into the water, about twenty feet deep. A man descended the rope on the instant, but the body could not be found until life was quite extinct.

PRISONERS.—On Saturday last about ninety-four prisoners, escorted by a lieutenant and twenty-seven rank and file of the 80th regiment, arrived here by the steamer; twenty of them were for Nobby's, and the rest for the chain gang.

ESCAPE.—A few days since a prisoner escaped from the chain gang, and has not since been heard of.

STATE OF THE GAOL.—The following was the state of H. M.'s gaol on Wednesday last:—For trial, males 50, females 8; for other stations, male 1; under sentence to hard labour, males 2, females 4; in the cells, males 2, females 2; debtor, female 1; confined, males 8, waiting for assignment, females 12; total, males 63, females 27. In hospital, males 3, females 7.

SINGLETON.—THE WEATHER.—Within the last fortnight we have had some beautiful showers of rain, which have put our farmers and gardeners in good spirits. The young wheat looks very promising; the gardens look remarkably well, and every description of garden stuff in season is very good, and very cheap.

MARKETS.—Flour remains as last quoted, namely, fine 10s per 100 lbs., seconds 14s, ration 12s. Many parties with whom we have conversed are of opinion that these prices are still too high in comparison to the prices in Sydney, and the present low price of wheat here. Butcher's meat is now only 2d per lb. for very good beef, and 1d for very prime mutton. Bread still remains at 4d the 2lb. loaf; eggs, from 10d to 1s per dozen; butter, 1s per lb.; fowls, from 1s 6d to 2s a pair.

THE ROADS.—In consequence of the late rains all the roads in this vicinity are in a dreadful state. As they are now constructed it is not to be wondered at; many of them are low in the middle and high at each side; consequently the rain has no outlet, but running in the roads until dried up by the sun and wind. Even in this thriving town it is impossible in some places to cross from one side of a street to another.

DURHAM ELECTION.—Last Saturday was the polling day here for the electors of Durham

resident in this district. Only 12 voted—6 for Oglivie, 4 for Windeyer, and 2 for Lang. Very few people attended, and the polling ended as it commenced, almost unnoticed.

We perceive by notices posted about the town that a public meeting is to be held in the court house on Tuesday next, on church affairs. The Lord Bishop of Australia will be present. It is to be hoped that something final will be agreed upon, and arrangements made for building a church and completing our school house, both of which buildings we stand much in need of.

SYDNEY NEWS.

SYDNEY BANK.—On Saturday last the adjourned meeting of the proprietors of the Sydney Bank was held at the office of the company, in George-street, to receive the report of Messrs. Moir, Sillitoe, and Brown, the committee who were appointed on the 17th June to investigate and report upon the affairs of the bank. The report of the committee was adopted by the meeting, and it appeared from it that the committee, having carefully examined the assets and liabilities of the bank, as they appeared on the evening of the 19th June, found there was a balance in favor of the bank of £10,038 11s. 6d. They considered the bills held by the bank as of a fair average nature of the bills current in the colony, and that the bank had incurred no risk beyond the risk incurred by every other similar establishment. The amount of overdue bills, £29,702 10s. 2d., included all since the establishment of the bank; a considerable amount of them were considered to be perfectly safe, and would be recovered without delay. The overdrawn accounts, amounting to £22,382 7s. 8d., appeared in many instances to have been admitted without the slightest regard to the interest of the bank, and contrary to the most common rules of prudence and discretion. These accounts had been considerably reduced since the suspension of the late manager. The liabilities of the bank had also been reduced £30,000 within the last two months, and the prospects of the company had altogether assumed a more favorable appearance. The committee recommended that no steps be taken by the proprietors until the general meeting after the half-yearly balance, when it would be in their power to judge what should be done for the benefit of all parties interested.

The committee for the election of Wentworth and Bland have determined, on the suggestion of Mr. Burdekin, to defray the expenses incurred by the contest, by means of a subscription, which we understand is now in progress.—Observer.

The criminal business of the supreme court has been postponed until Wednesday next, in consequence of Monday being the polling day for the county of Cumberland election.

During the last fortnight a number of counterfeit shillings and half-crowns have been in circulation; they are easily detected by their blue colour and vent of weight.

Private letters received in Sydney on Monday last mention the death of Colonel French, of H. M. 28th regiment.

On Saturday last the following persons were committed for trial at the next Quarter Sessions by the Windsor bench for rioting at Windsor during the election for the Cumberland Boroughs:—George Freeman, John Thruston, Edward Coffey, Samuel Freeman, and William Smith. They were all allowed bail.

Two black fellows named Fowler and Jemmy Jemmy, both notorious characters, have been committed for trial by the Port Macquarie bench for attempting to murder a watchman named Carroll, in the employ of Messrs. Betts, Pantan, and Kerr, at a station on the M'Leay, on the 4th of May last. Mr. Commissioner Massey and his troopers, who captured the above prisoners, are in pursuit of another man called Jackey Jackey, who was also engaged in the same affair. Another black fellow, called Terrah-Mithie, has also been apprehended at Rolland's Plains, in the Port Macquarie district, for the murder of three men at a station called Kogo, about six years ago.

That portion of the mail saved from the wreck of the Chatham was brought to Sydney by the Glenmore.

DISPUTED RETURN.—A petition against the return of Mr. William Bowman for the Cumberland boroughs is in course of preparation, on the ground of bribery. The alleged bribery, we understand, consists of the payment of a sum of money to a band, some of the performers in which were voters for the borough of Windsor.—Sydney Morning Herald.

The Andover arrived in Sydney from Liverpool on Wednesday last, having left that port on the 13th February. She met with very heavy weather shortly after leaving England, during which several of her sails and her topgallant masts were carried away. At one time she was thrown on her beam ends, and the sea made a clean breach over her; part of her cargo was thrown overboard, after which she righted. The steward was so much injured by being washed against the bulwarks that he was obliged to be sent back to England from Tenerife, where she put in to rest. On arriving off the Cape of Good Hope she again encountered bad weather, and her second officer, Mr. Leopold Phillips, was unfortunately washed overboard, and all efforts to save him were unavailing.

LATEST ON TALLOW.—Two hundred casks North American were sold by auction at 34s. 3d. to 45s. 6d.; 100 casks Odessa were bought in; and 100 casks East Indian were sold at 35s. 9d. to 40s. per cwt. The market is again lower. On the spot, St. Petersburg yellow candle is 44s. 6d. per cwt.; now tallow for the last three months of the year is offering at 43s. 6d. per cwt.—Trade report of the Morning Chronicle, February 11, 1843.

OPENING OF THE ST. LAWRENCE CANAL.—That immense work, the ship canal, which connects the St. Lawrence with the upper lakes, is completed, as will be seen by the following extract from the Kingston Whig of November 30:—"This forenoon the inhabitants of Kingston were greatly surprised by the arrival from Cornwall of the beautiful and capacious steamboat Highlander, Captain Stourms. This steambot was the first vessel that passed through the St. Lawrence Canal, which achievement she performed on Friday last. Although one of the largest steamboats afloat, the Highlander met with no difficulty in passing through the canal or locks."

The works preparatory to the commencement of cutting through the Isthmus of Panama are advancing rapidly. The entire length of this canal will be 40 miles, its breadth at the surface 135 feet, and its depth 20 feet. Mr. Morel, the engineer, estimated its cost at £200,000.

COMMERCIAL REMARKS.

There is little or no alteration in the grain market this week at Maitland. Wheat remains without any alteration whatever, and maize may be said to be a trifle on the advance. We understand that there has been a decided advance upon maize in Sydney, and during the past week it has been selling at 2s 6d, 2s 9d, and 3s per bushel, according to its quality; the price in Maitland may now be quoted at from 2s to 2s 3d per bushel.

In Sydney there is a demand for bran, which is selling at £5 15s per ton.

The prices of all kinds of stock still continue ruinously low; there is in fact nothing like a market price, and both cattle and sheep have in many instances been sold for what they would fetch; during the last week milking cows have been sold at £1 a head, fat bullocks at £2, and sheep at 3s 6d and 4s.

The Maitland butchers have, we hear, generally agreed to raise the price of meat to 3d per lb. Salt pork is selling by retail in the Sydney shops at 3d per lb.

In dairy produce, and all other articles of consumption, no alteration of prices has taken place.

We are happy to hear that Mr. Cox's soap manufactory is progressing well, and that the sales are increasing. We understand that as soon as some further arrangements are completed, Mr. C. intends to commence making scented soap.
