

time they gathered up the clothes of Weakly and Hurley and took them away, telling the former on their departure that if he left the hut for two hours they would blow his brains out. As soon as they had gone Weakly turned round, and saw Hurley lying on the floor, bleeding from the back, and groaning very much, completely naked. He got his hands at liberty, put a shirt upon Hurley and rolled him in a blanket, went to his own house, which was not far distant, and got a pair of trousers as quickly as possible, called upon two men to go and stop with Hurley, and then got a horse and rode to Maitland as quickly as he could, where he gave information to the police and obtained a doctor. Weakly positively identified Cooper as the man to whom he had bid good night in the paddock, and he had not the least doubt that Boddey was the man who had kept watch over him; Healy, he thought, was not there, but Kain very much resembled in height and general appearance the short man who was with Hurley.

Some further evidence was taken, which went to show that Cooper, Healy, and Boddey had been seen together in the afternoon not far from Hurley's hut; and either Boddey or Healy had said to a man named Boseley that they would knock out somebody's brains but they would have the price of a bottle of rum before they slept. They were remanded, and the man Kain was sent under the charge of two constables to Hurley's place to ascertain if the unfortunate man could identify him.

Kain, it appears, was apprehended by constable Kerr near Newcastle on Tuesday, he having been sent with a letter to the chief constable there by his master to be returned to government. He was taken to Hurley's hut the same evening, but the old man was very bad, and suffering extreme pain, which he said affected his eyesight; he felt satisfied, he said, that Kain was the man, though he could hardly venture to swear to him. Kain was again taken to him on Thursday morning, when there was good daylight, and Hurley was considerably better; he then at once identified him, and without the least hesitation swore positively that Kain was the man who shot him. All the four men were brought before the police bench again yesterday, and from the evidence of Dr. Eyde, who is in attendance on Hurley, it appeared that the muzzle of the gun must have been nearly close to the old man's back when he was shot, as the skin all about the wound was discoloured by the powder. The wound was just under the right shoulder blade, about the size of half a crown; it had fractured the bone and penetrated considerably towards the chest. The wound has since become more extensive. When first called upon Dr. Eyde considered the life of Hurley to be in imminent danger; he is now something better, but still lies in a very dangerous state, and spits blood. Some of the wadding has been extracted from the wound, but Dr. Eyde has not as yet been able to extract any of the shot.

After Dr. Eyde had given his evidence, some further evidence was given by the chief constable relative to two bags which were found upon Healy's dray, and which he said were given to him by Hurley, but which Hurley swears were stolen from him on the night he was shot, and by the men who committed the outrage.

Constable Kerr also gave some evidence as to the apprehension of Kain, and all the prisoners were then remanded until Tuesday next, in order to bring some additional evidence against them.

THEATRICALS.—In consequence of the inclement state of the weather on Thursday evening last, the amateur performances for the benefit of the Benevolent Asylum did not take place. There was, however, a dress rehearsal, at which a considerable number of ladies and gentlemen were present; and the manner in which the performers went through their respective parts was such as to call forth the repeated applause of the audience. Judging from the acting on Thursday evening, we should say that the performances on Monday evening next cannot fail to give satisfaction. We forbear to offer any further remarks at present. We understand that should the weather prove favourable there is likely to be a very crowded house.

THE CROPS.—The wheat crops in this neighbourhood look remarkably fine and strong. The early sown wheat is very forward, and has a most promising appearance. That which was later sown is also coming on very rapidly. The peach trees are now all in full bloom, and promise a very abundant crop. We do not recollect ever to have seen trees so thickly studded with blossoms as great numbers of the peach trees are this season in Maitland.

THE WEATHER.—During the greater part of the last week the weather has been very cold and lowering. On Thursday morning it commenced raining, and has been raining pretty freely without intermission since that time. There must also have been a considerable fall of rain up the country, as the river at Maitland has risen upwards of two feet during the last day or two.

HORSE STEALING.—This crime seems to be rather on the increase in the vicinity of Maitland. Scarcely a week passes over but we hear complaints from one or more parties of their horses having been lost, and the general impression seems to be that they have been stolen. If so, however, the thieves manage their business so adroitly as to escape detection. We hope this hint will have the effect of inducing a strict look out.

ST. JOHN'S TOTAL ABSTINENCE SOCIETY.—On Monday evening last the members of this society, to about the number of 120, took tea together in the Catholic school-room. The party was got up in order to prevent any loss falling upon Mr. and Mrs. Lynch, the purveyors on the previous Tuesday evening, when the weather was so unfavourable. The evening was spent in a very pleasant manner, and everything went off with good humour and hilarity.

WOLLUMBI.—Mr. John McDougall has been appointed poundkeeper, in the township of Wollumbi, in the room of Mr. Henry Nichols, dismissed.

HUNTER RIVER DISTRICT NEWS.
[FROM OUR CORRESPONDENTS.]

MUSWELLBROOK.
The valley of the Upper Hunter, acknowledged by almost every one capable of judging to be the finest tract of country in the colony, has been miserably barren and unfruitful during the past two years. The river itself, and all its tributaries, has been a mere chain of ponds, with miles of pebbly bed; the water holes being "few and far between." No gushing stream to refresh and vivify. The very pools themselves, in which were concentrated all the river moisture, were stagnant, and the water almost unfit for use,

from vegetable decomposition. On the surface of the soil the grass and herbage has been scanty and stunted in the extreme. The wheat and maize crops have been almost a total failure, seed time having upon the average absorbed more than harvest was found to yield. As for vegetables for the table, these have been, if possible, more scanty still. Not a native potato to be had, and the few specimens to be seen of that useful and favourite plant familiarly known as the cabbage were of such a meagre kind that any respectable ninth-part-of-humanity would to a certainty have disdained to try his measure upon them. Taken altogether for the last two years, the sterility of these districts has been extremely depressing. The country around here used formerly to be famed for its verdure, but the aridity of last summer, following upon a previous one nearly as bad, had almost originated a belief amongst us "that something ailed it now, the place was cursed." This winter, however, has been an exceedingly mild one, and during the last few weeks we have been favoured with many a day of genial showers. The river, although not altogether the Hunter "itself again," has at least assumed the appearance of a running stream; and, as Byron says, "there's music in the gurgling of a rill." It has had not only a gladsome sound, but has been a gladsome sight to all of us. For the last week nearly (and whilst I am writing it still continues) we have had almost uninterrupted rain—not a succession of heavily pattering thunder showers, but a rain so constant and so genial that every drop sunk as it fell into the lap of mother earth, giving an assurance of an early and an abundant supply of food for man and for beast. Nothing can exceed in appearance our young crops of wheat; and as there is now little chance of frost supervening, our visions of "damper" of our own growing, in all its glorious rotundity, leaves a vivid impress upon the imagination. Without any wheat crop within ourselves, and what with the low price of stock, and the high price of money, the last two years have sorely crippled our means; for now scarcely

A sows have we got;
Not a guinea or note
have we left to bless ourselves with; but our wheat carries with it the look of abundance, our wool is fast maturing for the clip, and if we are not able to afford all our former luxuries, or to bear ourselves so stylishly as of old, we have at least a goodly prospect of the necessaries of life.

NEWCASTLE.
POLICE OFFICE, AUGUST 18.—James Roach was charged with an assault on the person of Mary Maher, with the intent of seriously injuring her, and her property, by firing the house, in which the prisoner and his wife were lodged. He was found guilty of the offence, and sentenced to pay a fine of £5, and in default of payment to be imprisoned in Newcastle gaol for two months.—There has been very little business doing at the police office the last week; a few summary jurisdiction cases and the above assault forming the whole.

Business generally continues very dull; a great number of ticket of leave holders as well as free persons are out of employment.

NEW STEAMER.—There is a talk of a fresh steamer being started to this place from Sydney, at very moderate charges (we believe one half of the present rates). If the report be true, and we have reason to believe it is, it would tend materially to do away with the existing monopoly. It appears very feasible that preference would be given to the new company, as these are not times when the public can afford to pay such enormous charges for a passage of six or seven hours only, and for a dinner of the steamer's description the outrageous sum of 4s. 6d.—at a time too when provisions are to be purchased at a rate next to nothing. Many persons are deterred from proceeding to Sydney by the steamer solely on account of the expense. A labouring man cannot afford to pay ten shillings for a steerage passage, and many individuals actually go overland in preference to paying the out-of-the-way charges exacted by the steam company. We fervently trust that some spirited individuals will form an opposition company, to give (which we are assured it will) an impetus to trade.

STATE OF THE GAOL.—The following was the state of H. M. gaol on Wednesday last:—For trial at the Circuit Court, males 23; at the court of Quarter Sessions, males 24, females 2; for other stations, males 4; under sentence to hard labour, males 3, females 6; in the cells, males 4, females 1; debtors, male 1, female 1; confined, males 11; witness, male 1; waiting for assignment, females 10; total, males 71, females 20. In hospital, males 5, females 3.

MURRURUNDI.
SCHOOL AND CHURCH.—A meeting of the inhabitants of this district was held on Thursday, the 10th inst., at the court house, for the purpose of raising a subscription for the erection of a school house and temporary church. The meeting was respectively attended, and a liberal subscription list is now going the rounds of the district, for the above purposes. Upwards of £23 were also subscribed as a present to the Rev. Mr. Anderson for his past services as a clergyman amongst us.

THE CROPS, &c.—There is scarcely anything of importance passing in this district at present. The pleasing prospect of a fine spring and an abundant harvest has dispelled those fears which have of late years been so harassing to the agriculturist. The wheat crops look beautiful; indeed, I have never seen them surpassed. The early sown wheat is, of anything, too forward; should frost prevail after earing the result may prove fatal to it. There has been an abundant fall of rain on the Liverpool Plains and Namoi districts, the rivers being slightly flooded. It is rumoured that the blacks have again been committing depredations among the stock on the Big, Macintyre, and Barwin rivers; several lives are reported to have been sacrificed to the vengeance of these lawless savages.

BLACK CREEK.
The heavy rains during the past week have rendered the road to Singleton nearly impassable. But the present state of things in this case will not, I trust, last much longer, now the District Councils are nominated; and I trust the gentlemen forming that for Patrick's Plains will at the commencement of their sittings set about the matter in earnest; and they will, I am convinced, find that the line of road by Glendon will not only be the best, but also the most economical, which latter circumstance ought of itself to be a sufficient inducement in the present circumstances of the colony for them to prefer it.

SINGLETON.
It has rained incessantly here since yesterday morning. A heavy flood is now expected, which

would do serious injury to our low land crops. The river is already rising a little, and the roads are dreadful.

SYDNEY NEWS.

WHOLESALE PRICES OF COLONIAL FARM AND DAIRY PRODUCE IN THE SYDNEY MARKET DURING THE PRESENT WEEK.

WHEAT AND FLOUR.—No alteration has yet taken place in the price of these articles. MAIZE is a shade lower than last week, 2s to 2s 3d being the highest prices given for the best samples.

BARLEY AND OATS are very little in demand; 2s 5d is about the price given.

BRAN.—This article maintains its price well; it still realises from £5 to £6, according to the quality.

HAY—Oaten and Lucerne—may be quoted at about the same as last week.

PIGS.—There have not been so many pigs forced into the market this week; they are consequently maintaining a more steady price, and will sell tolerably well if sent in proper condition for market.

POULTRY AND EGGS are selling about the same as last week.

BUTTER.—This article has been in good demand during this week; that which is packed in kegs of about 50 lbs. is very readily purchased, that being the most convenient size for small shopkeepers. The price, however, still remains the same.

CHEESE there is little or no sale for at present.

TALLOW.—Good tallow is exchanged for soap at the manufactories; the price may be considered at the rate of about 3d per lb. No cash sales can as yet be effected.

BACON AND HAMS are still very dull of sale; they are very difficult at present to dispose of for cash, but if good may be disposed of in the way of barter.

POTATOES.—There has been no alteration yet in the potato market. This is the proper time to purchase good seed for sowing.

COLONIAL TOBACCO is dull of sale, and very difficult to dispose of for cash.

HIDES.—The best price at present given for hides is 1 1/2d per lb.

COMMERCIAL REMARKS.

As usual of late, we have again to report that trade is extremely dull; if anything, business seems to be drawing into a still narrower compass; there is literally nothing doing.

There has been scarcely any produce brought into Maitland from the settlers in the vicinity during the week, and the prices of all articles of consumption remain without the slightest alteration; although we have heard that there is a slight advance in the price of sugar, both imported and at the Canterbury works, in the Sydney market.
