Deeds relating to property of William Kent in New South Wales

- 1 Assignment from William Kent of Cheltenham to John Miller, bookseller of Lambeth, relating to freehold in lands and premises in New South Wales, 5 March 1836, and re-assignment from John Miller to William Kent, 3 September 1838. (1 vellum sheet)

On the verso is a receipt signed by William Kent for £348 received from John Miller.
- 2 Assignment from William Kent, wine merchant of Cheltenham, to John Miller, bookseller of Lambeth, relating to freehold in lands and premises in New South Wales, 24 May 1838. (1 vellum sheet)

On the verso are receipts signed by William Kent for £426.12.0 received from John Miller and by John Miller for £556.8.8 received from Phillip P. King.
- 3 Notice from John Miller to Phillip P. King and Messrs. Stillwell and Sons his agents of the assignment dated 24 May 1838 from William Kent to John Miller, 10 August 1838. (3pp)

Also receipts signed by William Kent for £556.8.8 received from Phillip P. King, 21 August 1838, and a receipt for £4.0.8 for preparing the re-assignment, 5 September 1838.
- 4 Power of attorney from Rev. Henry Tingcombe of Camden, New South Wales, to John Pakenham Stilwell (sic) of London to receive shares of Henry Tingcombe in the estate of Elizabeth Tingcombe, deceased, 14 March 1863. (2 vellum sheets)

William Kent (1799-1870) was the son of Captain William Kent (1760-1812), who first visited New South Wales in 1795 and who received land grants in the centre of Sydney. His son was born in the colony, but by 1828 was living in Cheltenham in England. Several farms of his father were sold between 1835 and 1841. Kent made a brief visit to Sydney in 1838-39. Captain Phillip Parker King, the son of Governor Philip King, acted in the sale of the properties in New South Wales.

The firm of Stillwell & Company amalgamated with the Westminster Bank in 1922.
